




Tumaini Children's Home Trust Deed was registered on 16th December, 2002, in Mombasa, Kenya. **TUMAINI** is the Kiswahili word for **HOPE**.

The **VISION** of the Trustees is:

"It is intended by means of appeals for subscriptions, donations and bequests to establish a home to provide treatment and accommodation for children suffering from Human Immune Deficiency Virus and Acquired Immune Deficiency Syndrome".





- ➤ To reduce the stigma associated with HIV/AIDs through education.
- To offer guidance and counseling in sexuality, STDs, and prevention of HIV/AIDs in older children.
- To raise funds for support and upkeep of the home, with long term plan to set up self-sustaining projects that will render the home self-reliant.

A **two-story home with** four Dormitories, a Recreational Hall, Study Room with 8 computers, a Library, Stores, a modern Kitchen with stainless steel fittings, freezers, refrigerators, cookers, a Laundry with 3 washing machines, a Play Field and Administration Offices. All these facilities are conducive to good living for the children who are housed here.

Currently 2023, at the Home there are 55 children - 24 girls and 31 boys. All are **orphans** assigned to the home by the County Children's Department. 21 of 55 are HIV positive and on ARVs.

4 are under 2 years {2 boys and 2 girls}.

15 aged 3 to 5 years {7 boys and 8 girls} attending nursery schools.

15 aged 6 to 13 years {8 boys and 7 girls} attending primary schools.

17 aged 14 to 18 years {11 boys and 6 girls} attending high schools.

1 boy aged 18 is awaiting university placement.

2 aged 22 – 1 boy and 1 girl are in university.

1 girl aged 22 is awaiting vocational training placement.

Staff - Parenting has been made possible by selecting staff who consider it an opportunity to serve whilst earning their livelihoods. 2 mothers are assigned to each dormitory and one mother to about 8 children. The male staff provide fatherhood to the children. The staff is the key to the wellbeing of the children. As children grow, they are motivated to be role models for the younger children. Currently 9 mothers constitute the Mother's Department, 4 for House Keeping, 3 for Kitchen, 4 for Administration, 1 Part Time for Internal Audit, 1 Security for Day, 1 Driver for the Van.

The average cost per year per child is approximately Kshs. 300,000 (GBP £2,000 or €2,500 or \$3,000). The trustees seek contributions from well-wishers to financially sponsor the cost per child.

Endowment Funds:

To sustain the home in perpetuity the Trustees have set up Endowment Funds. The principal donations are invested on Fixed Deposits and only the interest earnings are used. 5 Endowment funds have been set up:

- Administration to cater for staff costs and administration.
- Education to cater for the education of the children. 2.
- Medical to cater for the medical needs of the children.
- Maintenance to cater for the maintenance of the building.
- General to cater for daily food, beverage and rations.

Trustees are soliciting lump sum contributions into any one or more of the Endowment Funds or one off financial or material contributions. Appreciation and recognition are made accordingly on a Roll of Honour.

Kshs. 5 million named corporate endowment fund from companies / banks.

Kshs. 3 million named endowment fund for assigned purpose.

Kshs. 1 million recognitions as a Benefactor Trustee.

Kshs. 501,000 recognitions as a Benefactor Patron.

Kshs. 251,000 recognitions as a Benefactor Vice-Patron.

Any amount either into an endowment fund or general needs of the home.

1. TUMAINI CHILDREN'S HOME

Background historical information

Tumaini Children's Home is a typical example of **Humanity at Work**. The late Ms. Joan Smith, a British tourist found a very sick child and took that child to the hospital for treatment. After recovery the child was handed over to her uncle who on realizing that the child was HIV positive, abandoned the child in a bush to die due to the stigma. Late Joan Smith was so touched by the incident and decided that something had to be done. She conceived the idea of a Children's Home dedicated for care of such Children.

- > Dreams and Ideas create realities. She approached the Late Mr. Ajit Singh Bhogal whose advocacy brought many stake holders together. They made financial and professional contributions in building and managing the institutions for many years as Trustees and well-wishers to make Late Joan Smith's dream a reality.
- ➤ **Bamburi Holdings Ltd** donated the 2 plots on which exist the Home and the School. The Directors were Late Mr. Dalip Singh Obhrai 50%, Late Mr. Jaspaul Singh Kandhari 25%, Late Mr. Shukla 12.5%, and Mr. Iqbal Mirza 12.5%. Without this valuable land there would have been no home and affiliated Institutions.
- Tumaini Children's Home Trustees The Founder Trustees lead by Late Mr. Ajit Singh Bhogal, Late Ms. Joan Smith, Late Mr. Dalip Singh Obhrai, Late Mr. Kanyialal Pandya and retired Dr. (Mrs.) Uma Nathwani took on this mammoth task. Late Mr. Ajit Singh Bhogal's advocacy brought all of them together. He also solicited the first contribution of Sterling £20,000 from his friend Mr. Joginder Saddle to start the construction of the Home.

Dr. Kishor Mandaliya was appointed as Trustee in place of the Late Ms. Joan Smith. Dr. Varinder Singh Sur in place of the Late Mr. Dalip Singh Obhrai and Mr. Manoj Shah in place of the late Mr. Kanyialal Pandya.

In July 2015, Dr. (Mrs.) Nathwani retired from her Medical Practice as well as a Trustee due to her age and ill health.

In January 2016, Dr. Kishor Mandaliya was appointed as Trustee Chair, Dr. Varinder Singh Sur as Managing Trustee, Mr. Manoj Shah to continue as Trustee. In 2019, Mr. Nirmal Singh Dhanjal, a hotelier and businessman and Mr. Akash Rasiklal Devani, a lawyer were appointed as Trustees.

➤ Overseas Trusts – Since inception of the home in 2007 many overseas donors have played a significant role in building and managing the home and affiliated institutions.

- Tumaini Homes of Hope In the United Kingdom, it all started as Friends of Tumaini Children's Home. Mr. Keith Jefferies, Ms. Mary Leadbetter and the Late Ms. Joan Smith were key members. Mr. Keith Jefferies closed this Charity and Ms. Mary Leadbetter founded the Tumaini Home of Hope registered by the Charity Commission of England and Wales as Charity number 1119126. In 2013. They reregistered it as Tumaini Homes of Hope, UK as a Charitable Incorporated Organization (CIO) number 1155271 whose voting members are its Trustees.
- > Stoddart Funds- In 2014, a bequest was inherited by the UK Trust which has enabled Tumaini Children's Home Trustees to set up "The Stoddart Endowment Funds" for Education, Medical and Maintenance of the Home.
- > Tumaini Waisenhaus Förderverein (TWFV), an initiative of medical doctors in Germany was founded by Dr. Gudrun Esser (Dentist), her husband Dr. Reinhard Esser (Paediatrics Cardiologist), Dr. Beatrix Wiebe (Paediatrics Neonatologist), her husband Dr. Walter Wiebe (Paediatrics Cardiac Surgeon). It is a registered charity, and it has supported the Home since inception in 2007. Apart from providing Euros 30.000 for the construction of the second floor, and another Euros 11.000 for the Tumaini Outpatient Clinic in 2011, they have also provided medical care, equipment, medicines, and many valuable needs of the home. The present Chair is Dr. (Mrs.) Beatrix Wiebe. Currently they make a significant contribution annually towards the day to day running costs of the home, High School, Special needs, Vocational and University/College Education and In-patient Medical as and when needed.
- ➤ Tumaini Out-Patient Clinic Some children at the Home required special medical care, especially laboratory tests for monitoring their medical progress. Dr. Varinder Singh Sur with The Rotary Club of Bahari-Mombasa, the Rotary Club of San Diego, USA, the Rotary Foundation and the German Trust (TWFV) helped to set up the Out-Patient Clinic with top of the range Laboratory. All out-patient needs of the children including their annual comprehensive medical examinations are undertaken at the clinic. The fee at the Clinic is very reasonable and is open to the community, providing valuable services to them, the children, and the staff.
- > Sirio School it had full registration with the Ministry of Education and followed the laid down curriculum. From 2014 the children's education was sponsored from earnings of the "Stoddart Endowment Fund" including their uniforms, shoes etc. The school was open to the community. The fee structure was reasonable and affordable, but the school had to be closed due to sustained losses.
- ➤ A Vocational Training Institute has leased the property. They provide Vocational training much needed by the country. The rental goes to administration of the Home.

- ➤ The Late Dr. Kanaksinh Karsandas Babla, since 2015 donated a School Bus and funded the complete refurbishment of the school making it one of the finest in Mtopanga. He was the largest contributor to the Administration endowment fund.
- ➤ Mr. Mohamed Hussien Jaffer of Grain Bulk Handlers Ltd and Jaffer Foundation has set up a named contribution to the Administration endowment fund.
- > Sir Yusufali Charitable Trust pay monthly for the out-patient treatment of the children at the in-house Clinic. This has ensured good health of the children.
- > Tumaini Children's Home can be summed up as Friends and Visitors with an intention of doing good, coming together, creating committees, boards and trusts, putting up structures as needs arose, many a times getting into crisises, picking up the strings, achieving and building good will but eventually are at the level where they are looking at capacity building, good governance with accountability, compliance, institutional excellence, consolidation and self-reliance through strategic planning and Endowment Funds to Sustain the Home in Perpetuity.
- Tumaini has managed to provide a home for the children to live and grow up in, the schools provide them with their basic educational needs, the clinic their day-to-day medical needs and their spiritual needs are met as they are encouraged and facilitated to follow the faith of their choice. The majority attend Church services every Sunday. Socially they have an opportunity to integrate into the community around them. The children are encouraged to understand, accept, and help rebuild their lives and recover their worth and dignity to be better citizens morally, physically, psychologically, and economically. We rehabilitate the children through counseling, loving care and being close to healing their unpleasant past experiences and help them to cope effectively with the changing environment.
